Notice before admission.

Mr. R. Laxmikanth Reddy, learned Assistant Government Pleader for Home, takes notice for respondent Nos.1 to 3, waives further notice and seeks time to get instructions.

Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.4 to 6 by Speed Post with Acknowledgment Due and file proof of service before the Registry by the next date of listing.

Learned counsel for the petitioner submits that the petitioner has submitted a complaint dated 25.01.2026 before respondent No.3 to take action against respondent Nos.4 to 6 and despite the said complaint was acknowledged on 31.01.2026. Learned counsel further submits that subsequently, a notice dated 02.02.2026 under Section

94/179 BMS was issued by respondent No.3 to the petitioner directing to appear personally before respondent No.3 with all the supporting documents, receipts, bank transfer records, Whatsapp/communication records. Learned counsel further submits despite appearance of the petitioner in pursuance of the said notice, no action has been taken by respondent No.3 on the complaint filed by the petitioner.

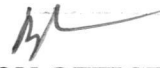
This matter requires detailed examination and the facts can be ascertained only upon filing written instructions/counter by the official respondents.
