WHEREAS the Petitioner above named through their Advocate SRI NARGIS AFSHAN KHAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction more particularly one in the nature of a writ of mandamus declaring the action of the Respondents in trying to demolish the ancestral property of the Petitioners bearing municipal No 5-4-494 and 489, admeasuring 55 Sq.Yds and 86.00 Sq.Yds respectively at Old Katalmandi, Nampally Station Road, Hyderabad and threatening to dispossess the petitioners without issuing notice/intimating the Petitioner and without following the due process of law as being illegal, arbitrary, unconstitutional, colorable exercise of power, and in violation of Article 14,19,21 and 300-A of the constitution of India and consequently direct the respondents not to dispossess the Petitioners from their ancestral property bearing municipal No 5-4-494 and 489, admeasuring 55 Sq.Yds and 86.00 Sq.Yds respectively at Old Katalmandi, Nampally Station Road, Hyderabad without following the due process of law pending disposal of the writ petition;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI NARGIS AFSHAN KHAN Advocate for the Petitioner, Learned Assistant Government Pleader for Home takes notice for respondent Nos. 1 to 3, directed issue of notice to the Respondent No.4 herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents not to dispossess the Petitioners from their ancestral property bearing municipal No 5-4-494 and 489, admeasuring 55 Sq.Yds and 86.00 Sq.Yds respectively at Old Katalmandi, Nampally Station Road, Hyderabad without following the due process of law pending disposal of the writ petition and may be pleased grant such other reliefs, pending disposal of WP No. 9073 of 2020, on the file of the High Court.

**Learned Counsel for the petitioners also submits that she will file additional documents to establish that the house constructed by the petitioners is only in an area admeasuring about 50 square yards, which is forming part of the land which has been purchased by the petitioners' predecessors bearing Door No. 5-4-494.**
