Petitioner above named through her Advocate Sri M.V.RAJ KUMAR GABRIEL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, to declare the action of Respondents in entertaining an application in Bhu Bharathi Portal with request to issue pattedar book under Court Case PPB Modul in respect of Sy. No.408/Ru (extent Ac.2.00 gts, situated at Bommaraspet Village, Shamirpet Mandal, Medchal - Malkajgiri District and consequential notice Dt.12-01-2026 issued by the 5th Respondent in respect of the said property as illegal, arbitrary, in violation of procedure established by law, contrary to the orders passed in WP No. 32514 of 2022, in violation of Article 14, 21 and 300-A of Constitution of India, contrary to the provisions of Telangana Bhu Bharathi (ROR) Act, also barred by limitation and against all settled principles of law and consequently set aside vide Notice No.E1/830-54/2025, Dt.12-01-2026 and direct the Respondents to delete the prohibition in respect of the petitioner's

agriculture land in Sy.No.408/Ru to an extent of Ac.2-00 gts, situated at Bommaraspet Village, Shamirpet Mandal, Medchal Malkajgiri District and to pass

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents Nos.3 to 6 not to change the existing entries in favour of the Petitioner in revenue records and in Bhu Bharathi Portal in respect of the petitioner agricultural land in Sy.No.408/Ru, to an extent of Ac.2-00 gts. situated at Bommaraspet Village, Shamirpet Mandal, Medchal Malkajgiri District, pending disposal of WP No.7749 of 2026, on the file of the High Court.
