WHEREAS the Petitioners above named through their Advocate Sri GUDI MADHUSUDHAN REDDY presented this Petition Under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent No 2 in issuing the proceedings vide No. Case No E3/46/2025 dated 21.2.2026 to restore the entries prior to the mutation in the year 2007 for the lands in survey No. 147, 148 and 149 extent ac 27.14 gts situated at Itikalapally village of Bachannapet Mandal, Jalgaon District while pending suits vide OS No.345/2019 on the file of Addl. District Judge at Jangaon and also without conducting any enquiry as directed by this Hon'ble court in WP No.269/2025 dated 06.01.2024 and WP No.27064/2025 dated as arbitrary and illegal and also contrary to law

laid down by full bench of this Hon'ble court in Chinnam Pandurargam vs. Mandal Revenue Officer reported in AIR 2008 AP 15 after a period of 19 years without considering the documents and grounds raised by the petitioners as arbitrary and illegal and in violation of the principles of natural justice and further against the death persons consequently set aside the same;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri GUDI MADHUSUDHAN REDDY Advocate for the Petitioner and GP for Revenue for Respondent Nos.1 to 4, directed issue of notice to the Respondent Nos.5 and 6 herein to show cause as to why this WRIT PETITION should not be admitted.

***Status quo*, obtaining as on today, shall be maintained in respect of revenue entries over the subject land admeasuring Acs.27.14 guntas in Survey Nos.147, 148 and 149 situated at Itikalapally Village of Bachannapet Mandal, Jangaon District, till the next date of hearing.**
