Mr. E.Ravinder Reddy, learned Assistant Government Pleader for Agriculture and Cooperation Department, appears for respondent Nos.1 and 2. Dr. N.Uma Shankar, learned Standing Counsel for Agricultural Market Committee, appears for respondent Nos.3 and 4. Learned counsel for the appellant/respondent No.5 submits that the impugned order dated 03.05.2024 passed by learned writ Court in W.P.No.17873 of 2016 has directed allotment of Shop No.1-B in favour of	

		respondent No.5/writ petitioner, whereas respondent No.5 was allotted the said shop in 2016 after a due action process. The Review I.A.No.1 of 2024 in W.P.No.17873 of 2016 filed by the State was also dismissed. The appellant has preferred W.A.No.350 of 2026 against the original order dated 03.05.2024 passed in W.P.No.17873 of 2016 and W.A.No.349 of 2026 against the order dated 08.10.2025 passed in Review I.A.No.1 of 2024 in W.P.No.17873 of 2016. Learned counsel for the appellant submits that a contempt petition has been filed by respondent No.5/writ petitioner which is posted for 26.03.2026. However, it appears that the name of learned counsel for respondent No.5/writ petitioner is not reflected in the cause list. Learned Assistant Government Pleader for Agriculture and Cooperation Department appearing for respondent Nos.1 and 2 and learned Standing Counsel for Agricultural Market Committee appearing for respondent Nos.3 and 4 are present. Therefore, let the name of learned counsel for respondent No.5/writ petitioner be reflected in the cause list. Let the matter appear on 31.03.2026.
