WHEREAS the Petitioner above named through their Advocate SRI SYED MOUNIS JAFER ABIDI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ/order/direction more particularly one in the nature of Writ of Certiorari to call for the records pertaining to the impugned order passed by Respondent No.2 in Case No. A/1267/2024 dated 20-02-2026 directing the respondents to vacate the property bearing H.No. 18-2-43/3/A/33, GM Colony, Chandrayangutta, Hyderabad within 30 days and to consequently quash and set aside the same as illegal, arbitrary and contrary to the provisions of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 (MWPSA Act).
