The petition coming on for hearing, upon perusing the petition and the grounds filed in support thereof and upon hearing the arguments of Sri Akkam Eshwar, Advocate for the Petitioners and Addl. Public Prosecutor for the Respondent No.1, the Court made the following.

ORDER:

Learned counsel for the petitioners submits that pursuant to the order dated 18.03.2026, he sent personal notice to respondent No.2 by way of speed post and acknowledgment due and the same was returned with postal endorsement as 'no such person in the said address'.

In view of the same, to render substantial justice to the parties, learned Additional Public Prosecutor is directed to serve the notice to respondent No.2 through the concerned S.H.O. and file proof of service.

The presence of the petitioners/accused Nos.4, 5, 10 and 13 in S.C.No.692 of 2018 on the file of the XV Additional District and Sessions Judge-cum-II Additional Family Judge, Ranga Reddy District, at Kukatpally, is dispensed with, subject to the condition that they shall be represented through their counsel on each and every date of hearing. If the presence of the petitioners/accused Nos. 4, 5, 10 and 13 is required, they shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for their appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
