WHEREAS the Petitioner above named through her Advocate SRI KOPPULA GOPAL presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction more particularly one in the nature of WRIT OF MANDAMUS declaring the action of the 3rd respondent herein in frequently interfering into the peaceful possession and enjoyment of the petitioner's agricultural land admeasuring Ac. 1.14 guntas in Sy No. 169/15, situated at Tattapally Village, Peddemul Mandal, Vikarabad District at the instance of the 5th respondent herein, even inspite of the pendency of the suit being O.S No. 266 of 2025 and ad-interim injunction dated 25.11.2025 granted by the Additional Junior Civil Judge, Tandur, Vikarabad District in IA No. 229 of 2025 in O.S No. 266 of 2025 in favour of the petitioner herein is being illegal, arbitrary, unreasonable and violation of Article 14 and 300-A of the Constitution of India and violation of principles of natural justice and contrary to the ad-interim injunction order dated 25.11.2025 passed in IA No. 229 of 2025 in OS No. 266 of 2025 and consequently direct the 3rd respondent herein not to interfere into civil disputes without following the procedure contemplated under the law.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI KOPPULA GOPAL Advocate for the Petitioner, SRI M. SRINIVAS AGP FOR HOME for the Respondents No. 1 to 3 and SRI K. MAHESH, AGP FOR REVENUE for the Respondent No.4 directed issue of notice to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 01.04.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the 3rd respondent herein not to interfere/ not to dispossess from the petitioner's agricultural land admeasuring Ac. 1.14 guntas in Sy No. 169/15, situated at Tattepally Village, Peddemul Mandal, Vikarabad District, pending disposal of WP No. 8396 of 2026, on the file of the High Court.

**ORDER:**

**Notice Before Admission.**

**Mr. M.Srinivas, learned Assistant Government Pleader for Home takes notice on behalf of respondent Nos.1 to 3 and seeks short accommodation to obtain instructions.**

**Mr. K.Mahesh, learned Assistant Government Pleader for Revenue takes notice on behalf of respondent No.4 and also seeks short accommodation to obtain instructions.**

**Issue notice, including personal notice to respondent No.5.**

**The proof of service to be filed by the next date of hearing.**

**Learned counsel for the petitioner submits that without there being any power conferred upon the respondent No.3 is interfering in the peaceful possession and enjoyment of the petitioner's land admeasuring Ac.1.14 guntas in Survey No.169/15 situated at Tattepally Village, Peddemul Mandal, Vikarabad District and also exerting pressure upon the petitioner to appear before the authorities, where the petitioner was granted Injunction order in I.A. No.229 of 2025 in O.S. No.266 of 2025 on the file of Additional Junior Civil Judge, Thandur, Vikarabad District.**

Learned Assistant Government Pleader by providing written instructions would submit that based upon the letter addressed by the Tahsildar, Peddemul Mandal to the Sub-Inspector of Police, Peddemul Police Station *vide* Lr. No.C/168/2026 dated 10.03.2026 requesting to provide police protection to the said land, police security is provided to the said land.

On careful perusal of the proceedings issued by respondent No.4, it is surprising to note that nowhere it has been stated that 145 Cr.P.C. (164 BNSS) has been issued as contemplated under law.

This requires detailed examination.

In the meanwhile, the respondent No.3 is directed not to interfere with the *inter se* personal disputes between the petitioner and respondent No.5.
