Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, Order or Direction, or any other appropriate Order one in the nature of a WRIT OF MANDAMUS, declaring the action of the Respondent No.2 issuing Endorsement proceedings vide No.R1/76669/2018 dated 22.09.2025 and not regularizing the property under GOMS.No.59 inspite of submitting application dated 15.03.2022 with all relevant documents and interfering into the peaceful possession and enjoyment of the Petitioner H.No.9-11-121/A/ 1, 9-11-121/A, 9-11-121/B and 9-11-121/B/2 to an extent of 2000 Sq. yards situated opposite to Dowlath Khana (Moti Mahal), Jinsi Bazar, Golconda Fort, Hyderabad, as illegal, arbitrary and violation of principles of natural justice, and consequently set aside Endorsement proceedings vide No.R1/ 76669 /2018 dated 22.09.2025 issued by the Respondent No.2 by directing the Respondents to regularize the Petitioner's property as per GOMS.No.59 and not to interfere into the peaceful possession and enjoyment of the Petitioner over H.No.9-11-121 /A/ 1, 9-11-121/ A, 9-11-121/B and 9-11-121/B/2 to an extent of 2000 Sq. yards situated opposite to Dowlath Khana (Moti Mahal), Jinsi Bazar, Golconda Fort, Hyderabad.
