WHEREAS the Petitioners above named through their Advocate SRI M V HANUMANTHA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any Writ, order or direction more

particularly one in the nature of Mandamus declaring action of the respondent No. 4 in filing E.P.No. 197 of 2024 IN ABR/CF/No. 242 of 2023 on the file of learned I Senior Civil Judge/City Civil Court, Hyderabad for execution of exparte award dt. 28/02/2024 passed by the respondent No.3, as illegal, arbitrary, and contrary to the provisions of the Chit Funds Act, 1982 and Rules and against the law held by this Court in Punyamurthala Venkata Viswa Sundara Rao -Vs- Margadari Chit Fund Private Limited, Hyderabad & others [reported in 2017 (3) ALD 387] and consequently to declare that E.P.No. 197 of 2024 IN ABR/CF/No. 242 of 2023 filed by the respondent No.4 is not maintainable and the same is liable to be rejected.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI M V HANUMANTHA RAO Advocate for the Petitioners, and GP FOR STAMPS & REGISTRATION for the Respondent Nos.1 to 3 directed issue of notice to the Respondent No.4 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 10.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

The Court made the following:
ORDER:

Notice before admission.

Issue notice to respondent Nos.4 to 7.

Learned counsel for the petitioners is permitted to take out personal notice on respondent Nos.4 to 7 through Speed Post with Acknowledgment Due and to file proof of service in the Registry by the next date of hearing.

The learned counsel for the petitioners submits in Punyamurthula Venkata Viswa Sundara Rao v. Margadarsi Chit Fund Private Limited, Hyderabad and others [2017(3) ALD 387], the Division

Bench of this Court held that the E.P. Court does not have jurisdiction to entertain an application for execution of the award passed by the Deputy Registrar of Chit Funds, if presented by the decree holder.

In the instant case also, it appears, straight away E.P.No.197 of 2024 in ARB/CF/No.242 of 2023 was filed before Court of the I Senior Civil Judge, City Civil Court, Hyderabad, against the petitioners and others, without it being presented/forwarded by the Registrar. In view of the decision referred to above, balance of convenience is in favour of the petitioners.
