WHEREAS the Petitioner above named through his Advocate SRI V. SRIKANTHA RAO presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or Direction, more particularly one in the nature of a Writ of mandamus declaring the action of the Respondents No.3 and 4 in sending recovery agents to the residence of the petitioner and threatening him pay the loan amount Rs 10,624.30 having knowledge about death loan account holder who is son of the petitioner with the dire consequences, if loans are not repaid as illegal, arbitrary and against Article 14, 19 21 of the constitution of India and also in violation of the Circular guidelines and instructions, dated 12.08.2022 issued by the Reserve Bank of India and also the observations in the judgments of the Apex Court consequently to direct the Respondent Nos.3 and 4 to forthwith stop sending recovery agents to the Petitioners residence and follow procedure as contemplated by law to recovery any loans that may be due to the Respondents.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI V. SRIKANTHA RAO Advocate for the Petitioner and SMT. N.V.R. RAJYALAKSHMI, Standing Counsel for Central Government appearing

on behalf of SRI N. BHUJANGA RAO, DEPUTY SOLICITOR GENERAL OF INDIA, for the Respondent No.1 directed issue of notice to the Respondents No. 2, 3 and 4 herein to show cause as to why this WRIT PETITION should not be admitted.
