Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly a Writ of Mandamus, declaring the action of the Fourth Respondent -Tahsildar/MRO, Wardhannapet Mandal, in issuing the impugned proceedings in Proc.No.B/255/2025, pursuant to the representation bearing Grievance No.WGRCD/E/2025/03097 dated 15.09.2025, whereby directions were issued permitting the alleged usage of a pathway through the petitioner's private patta land admeasuring Ac.0-04 guntas in Survey No.111/2/2 of Divitipally Village, Wardhannapet Mandal, despite the existence of a pending civil dispute in O.S.No.158 of 2024 on the file of the IV Additional Junior Civil Judge at Warangal, as illegal, arbitrary, without jurisdiction, and violative of the petitioner's constitutional and property rights, and consequently set aside the said proceedings.

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to stay the operation, implementation, and all further proceedings pursuant to the impugned order issued by the Fourth Respondent in Proc.No.B/255/2025, and consequently restrain the respondents, their agents, subordinates, or any person claiming through them from interfering with the peaceful possession and enjoyment of the petitioner over the land admeasuring Ac.0-04 guntas in Survey No.111/2/2 of Divitipally Village, Wardhannapet Mandal, covered under Registered Sale Deed No.944/2024 dated 05.12.2024, pending disposal of WP No 8944 of 2026, on the file of the High Court.

The petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SRI KODARI MALLIKARJUN Advocate for the Petitioner and GP FOR REVENUE appears for the Respondents no. 1 to 4, the Court made the following.

ORDER:

Await service of notice sent to respondent Nos.5 and 6.

***Status quo*, obtaining as on today, shall be maintained in respect of land admeasuring Ac.0-04 guntas in Survey No.111/2/2 of Divitipally Village, Wardhannapet Mandal, till the next date of hearing.**
