WHEREAS the Petitioners above named through their Advocate Sri V V RAMANA, presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate order, writ or direction more particularly one in the nature of writ of Mandamus challenging the inaction of the Respondent No.5 in not deleting the illegal entries in the Revenue Records in favour of the respondent nos 6 and 7 in respect of griculture land admeasuring Ac.05.22 guntas in respect of Sy.No.398 and Ac.10.00 gnts., in Sy.No. 402 total admeasuring Ac.15.22 gnts., situated at Kondakal Village, Shankerpally Mandal, Ranga Reddy District consequently delete the name of the respondent nos 6 and 7 and its illegal entries in the Revenue Records by cancelling the pass book in their favour and issue the pattadar pass books and title deeds to the petitioner by rectifying the entries in Revenue Records including Dharani Portal;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri V V RAMANA, Advocate for the Petitioners, GP FOR REVENUE, for Respondent Nos. 1 to 5, directed issue of notice to the Respondent Nos. 6 and 7, herein to show cause as to why this WRIT PETITION should not be admitted.
