Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the Respondents No. 3 to 5 to permit the Petitioner to organize and conduct Lord Sri Rama ShobhaYatra on 27.03.2026 on the eve of Sri Ramanavami in Bhainsa Town, Nirmal District pending disposal of WP No. 8840 of 2026, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Heard learned counsel for the petitioner.

Learned counsel for the petitioner would submit that the application of the petitioner vide Application No.1521170326180159262, dated 17.03.2026 has been rejected on 18.03.2026 by the respondent No.4 and the said order has been uploaded only on 23.03.2026. He would submit that in similar circumstances in the earlier round of litigation, the Co-ordinate Bench of this Court vide orders dated 04.04.2025 passed in I.A.No.1 of 2025 in W.P.Nos. 10230, 10238 and 10253 of 2025 had granted interim order and permitted the petitioners therein to organize processions subject to the following conditions:-

- (i) the subject procession shall be taken up between 10.00 a.m. and 6.00 p.m.
- (ii) the petitioners shall use only (01) DJ sound system during the procession, which shall comply with the noise levels prescribed by the Central Pollution Control Board in residential areas and commercial areas.

Learned counsel relied upon the interim order passed by the Co-ordinate Bench of this Court in W.P.No.9555 of 2024 where in I.A.No.1 of 2024, the Court has granted interim order in favour of the petitioner therein.

Learned counsel also relied upon the orders dated 08.04.2022 passed in W.P.Nos.18037, 18044 and 17767 of 2022 and submits that the case of the petitioner is similar to that of the above Writ petitions and that no crime has been registered against the petitioner during the last occasions and hence requested to pass appropriate orders.

This Court having perused the material available on record and after hearing the learned counsel for the petitioner and the learned Assistant Government Pleader for Home, deems it appropriate to pass interim order as under :-

In the circumstances, taking into consideration of the order of this Court dated 28.03.2023 in W.P.No.8678 of 2023, there shall be interim direction to the respondents to permit the petitioner to organize Lord Sri Rama Shobha Yatra on 17.04.2024 between 10.00 a.m. to 1.00 p.m. on the eve of "Sree Rama Navami" festival celebrations in Bhainsa Town, Nimal District. The petitioner shall not play music system within 150 meters of the nearby mosques in Bhainsa Town. The petitioner shall also ensure that the persons with criminal antecedents do not participate in the Shobha Yatra. The participants shall not raise any communal and politically sensitive and provocative statements during the programme.
