WHEREAS the Petitioner above named through his Advocate SRI GUMMALLA BHASKER REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction more particularly one in the nature of mandamus declaring the action of the respondents Nos. 3 to 5 in refusing permission to the Petitioner to organize Lord Sri Rama ShobhaYatra on 27.03.2026 on the eve of Sri Ramanavami in Bhainsa Town, Nirmal District as illegal, arbitrary and violation of the articles 14,19 and 25 of the constitution of India and consequentially direct the Respondents No. 3 to 5 to permit the Petitioner to organize and conduct Lord Sri Rama ShobhaYatra on 27.03.2026 on the eve of Sri Ramanavami in Bhainsa Town, Nirmal District in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI GUMMALLA BHASKER REDDY Advocate for the Petitioner and AGP FOR HOME for the Respondents No. 1 to 5 directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
