WHEREAS the Petitioner above named through her Advocate Ms. Bethamacharla Sai Haritha presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an appropriate Writ or direction, more particularly a Writ in the nature of Mandamus, declaring the action of the Respondents in disconnecting the electricity service connection bearing Service No. 12126-07416-14354450 at the Petitioner's premises situated at H.No. 30-2-1151/4, TNGO Colony, Madikonda Village, Kazipet Mandal, Hanumakonda District, by

setting aside the impugned notice in violation of the principles of natural justice, as illegal, arbitrary, highhanded and violative of Articles 14 and 21 of the Constitution of India.
