WHEREAS the Petitioner above named through her Advocate SRI PALLY VINOD KUMAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction, more particularly one in the nature of writ of mandamus declaring the action of the respondents, particularly Respondent No.7, in fraudulently removing the name of the petitioner and replacing it with the name of Respondent No.8 in the official records relating to House No.2-48/3 of Bollaram Gram Panchayat and issuing Property Tax Assessment No.157 with PTIN No.320207400157 in favour of Respondent No.8, as illegal, arbitrary and violative of Articles 14 and 21 of the Constitution of India, and consequently set aside and cancel Assessment No.157 and PTIN No.320207400157 issued in favour of Respondent No.8, direct the respondents to restore the name of the petitioner, Burra Laxmi W/o Burra Anjaiah, as the rightful beneficiary and property holder in the official

Gram Panchayat records pertaining to House No.2-48/3 of Bollaram Gram Panchayat, direct the respondents to consider and act upon the petitioner's representation dated 11.03.2026 submitted to the 2nd respondent, and further direct the competent authorities to conduct a detailed enquiry into the manipulation of official records and corruption by Respondent No.7 and take appropriate disciplinary and criminal action;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri PALLY VINOD KUMAR REDDY Advocate for the Petitioner, AGP FOR PANCHAYATH RAJ AND RURAL DEV. For respondent No.1, AGP FOR REVENUE for respondent Nos. 2 to 5, directed issue of notice to the Respondent No.8, herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 10.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to set aside and suspend the operation of Property Tax Assessment No.157 and PTIN No.320207400157 issued in favour of Respondent No.8 and consequently direct the respondents to restore the name of the petitioner, Burra Laxmi W/o Burra Anjaiah, in the official records pertaining to House No.2-48/3 of Bollaram Gram Panchayat, forthwith, pending disposal of WP No. 8974 of 2026, on the file of the High Court.

**The Court made the following:
ORDER**

Notice before admission.

Learned Assistant Government Pleader for Panchayath Raj and Rural Development appearing for respondent No.1 seeks time to obtain instructions and make submissions.

Learned Assistant Government Pleader for Revenue appearing for respondent Nos.2 to 5 seeks time to obtain instructions and make submissions.

Learned Standing Counsel for respondent Nos.6 and 7 seeks time to obtain instructions and make submissions.

Issue notice to respondent No.8.

Personal notice is permitted.

Learned counsel for the petitioner submits that respondent No.7, had fraudulently removed the name of the petitioner in the official records relating to H.No.2-48/3 of Bollaram Gram Panchayat and issued property Tax Assessment No.157 with PTIN No.320207400157 in favour of respondent No.8. Aggrieved by the same, the petitioner filed a detailed representation dated 11.03.2026 before the respondent No.2/District Collector, Rajanna Sircilla District. To that effect, he relies on the copy of postal receipt/Tracking Report. But no action has been taken by respondent No.2 so far. Therefore, he seeks to pass appropriate orders.

On hearing the submissions of learned counsel for the petitioner and on perusal of the material available on record, this Court, without making any observations on the merits or demerits of the case, deems it appropriate to grant liberty to the petitioner to file an appropriate representation before respondent No.3, who would in turn examine the case of petitioner and conduct enquiry, by affording reasonable opportunity of hearing to respondent Nos.7 and 8 and pass appropriate orders, strictly in accordance with law.
