WHEREAS the Petitioner above named through her Advocate Sri MOHD ASIFUDDIN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a proper writ order or orders, particularly one in the nature of Writ of Mandamus

(a) to declare the action of the respondents No. 2 and 3 in not taking further action in pursuance to the FIR.No. 287 of 2026 dated 14/03/2026 for the offences punishable under Section 329 (4), 351 (2) 115 (2) r/w 3 (5) BNS,

(b) to declare the action of the respondents No. 2 and 3 in not providing petitioner police protection against the respondents No. 4 to 11 inspite of petitioner representation dated 16/03/2026 and 20/03/2026

(c) to declare the action of the respondents No. 2 and 3 in not providing protection of petitioner life and property as per Article 21 and 300-A of the Constitution of India and as envisaged under the Section 22 of the Maintenance and Welfare of Parents and Senior Citizens Act, 2007 inspite of petitioner representation dated 16/03/2026 and 20/03/2026 as arbitrary, highly illegal and in violation of fundamental legal rights.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri MOHD ASIFUDDIN Advocate for the Petitioner, directed issue of notice to the Respondent Nos.4 to 11 to show cause as to why this WRIT PETITION should not be admitted.
