Taking into consideration the submissions made by the learned counsel appearing on behalf of the petitioner that the order dated 07.01.2025 passed in favour of the petitioner by this Court in W.P.No.399 of 2025 had not been implemented as on date and the said fact having not been disputed even by the learned counsel appearing on behalf of the respondents and duly taking into consideration the averments made in the affidavit filed by the petitioner in support of the present writ petition, in particular para 9, *status quo* existing as on date is directed to be maintained in respect of the land admeasuring Ac.15.23 gts., in Sy.No.99/2 situated at Mamidipally Village, erstwhile Saroornagar Mandal, now Balapur Mandal, Ranga Reddy District, till 15.04.2026.
