WHEREAS the Petitioner above named through his Advocate SRI RAMESH KADARI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or direction more particularly one in the nature of writ of Mandamus declaring the action of the respondents 2 and 3 in not taking any action on the representations made by the petitioner dated 24.05.2025, 22.09.2025, 23.6.2025 and 02.02..2026, for conducting enquiry and grant of compensation in favour of the petitioner in respect of the agricultural land in Sy.No. 27/14, admeasuring Ac.2-05 Gts., situated at Mamidigi Village, Nyalkal Mandal, Sangareddy District, now showing the names of others in Dharani Portal / Bhu Bharathi Portal as highly illegal, arbitrary and in violation of Article 300-A of the Constitution of India, consequently direct the respondents to forthwith take action on the representations made by the petitioner dated 24.05.2025, 22.09.2025, 23.09.2025 and 02.02.2026, by conducting enquiry pertaining to the entries in respect of the agricultural land in Sy.No. 27/14, admeasuring Ac.2-05 Gts., situated at Mamidigi Village, Nyalkal Mandal, Sangareddy District in Dharani / Bhu Bharati and to initiate proceedings for grant of compensation in favour of the petitioner.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI RAMESH KADARI Advocate for the

Petitioner, directed issue of notice to the Respondent Nos.6 and 7 herein to show cause as to why this WRIT PETITION should not be admitted.
