WHEREAS the Petitioner above named through his Advocate M/s Om Law Firm presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ order or a direction, more particularly one in nature of Writ of Certiorari Calling for the records pertaining to Memo No. 0014/SA/2018-20 dated 18. 09. 2020 issued by – 5th Respondent and set aside the same holding the same as illegal and violative of law and also direct the 5th Respondent to sanction pension and gratuity to the Petitioner who worked as a Driver since 1987 to 2020 i.e. 33 years of service without any remark for the Respondents as sanctioned to others in the similar circumstances and also declare the action of the Respondents in not sanctioning pension and gratuity to the Petitioner, as given to others in the similar circumstances as arbitrary, unjust and violative of Article 14, 21 of the Constitution of India;
