WHEREAS the Petitioner above named through his Advocate SRI K SUYODH REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate order, direction, or Writ, more particularly one in the nature of a Writ of Mandamus, declare action of the Respondent No. 2 in issuing proceeding vide Rc.No. 2128739/ 2023-HS4 dated 19.02.2026 in partial compliance of the orders passed by the this Honble Court in Writ Petitioner vide W.P No.199 of 2026, date.20.01.2026, as illegal, highhanded, arbitrary and violative of Sections 23-A(1)(a) to 23-A(1)(d) of TMACS Act,1995, apart from being violative of Article 14 and 19 of the Constitution of India and with a consequent prayer to set-aside the proceeding of Respondent No. 4 vide Rc.No. 01/Coop.Elections/ Vishnu Vista-MACS/2026 dated 16.03.2026 and all other incidental proceedings/actions including Vide Rc No. 03/Elections/MACS/Vishnu/2026, dated 24.03.2026 and a consequent prayer to dissolve the erstwhile board of four directors namely B.G.S.S. Chakravarthy, K.

Ranganath, Ravi Chandra Prasad Katari and Sammeta Suresh Babu in accordance Sections 23-A(1)(a) to 23-A(1)(d) of TMACS Act, 1995;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri K SUYODH REDDY Advocate for the Petitioner, directed issue of notice to the Respondent Nos. 4 and 5, herein to show cause as to why this WRIT PETITION should not be admitted.

Issue notice to respondent Nos.4 and 5.

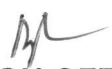
