Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the inaction of the Respondents in not appointing the petitioner in the post of Junior Lineman by conducting pole climbing test inspite of the petitioner having prescribed educational qualifications in the notification No.1/2019 dated 28-09-2019 as illegal, arbitrary, discriminatory and violation of articles 14, 16 and 21 of the Constitution of India and consequently direct the respondents to appoint the petitioner in the said post by setting aside the clause No.(3) in notification No.1/2019 dated 28-09-2019 which is unconstitutional and

discriminatory and depriving the rights of the petitioner in getting the post of Junior Lineman in the state of Telangana.

IA NO: 1 OF 2024

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondents to conduct pole climbing test for appointing the petitioner as Junior Lineman by recognizing the national trade certificate issued by the National Council for vocational training and entrepreneurship and its validity over all the country which is equivalent to ITI Certificate of the Telangana State and State of Andhra Pradesh, pending disposal of WP 9898 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of DR. KADIRI KRISHNAIAH Advocate for the Petitioner, SMT K. UDAYA SRI, Standing Counsel for respondent No.1 SRI R VINOD REDDY, standing Counsel for the Respondent No.2 to 4, the Court made the following.
