ORDER:

Learned Advocate General for the State of Telangana is out of State in connection with matters before the Hon'ble Supreme Court. Therefore, a prayer for adjournment has been made by Mr. M.B.Nitish, learned Assistant Government Pleader representing learned Advocate General.

Ms. B.Rachna Reddy, learned Senior Counsel appears on behalf of Mr. Mohd.Baseer Riyaz, learned counsel for respondent No.1 in W.A.Nos.507 and 524 of 2025 and the appellant in W.A.No.625 of 2025 (writ petitioners in W.P.Nos.11706 of 2019 and 10777 of 2019).

Learned Senior Counsel submits that the writ petitioner in W.P.No.11706 of 2019 is not able to participate in any tender as his status in the approved list of special class contractors has not been restored despite the direction given in the impugned judgment dated 20.01.2025 in W.P.No.11706 of 2019, which has not been stayed by this Court.

Learned counsel for the State submits that on the next date, he would apprise this Court on the decision taken on the representation of the writ petitioner in W.P.No.11706 of 2019 in the light of the direction contained at para 15 of the impugned judgment dated 20.01.2025.

Learned counsel for the parties undertake to submit a comprehensive list of dates and a brief synopsis.

Let all the three cases be listed together on 13.08.2025.
