WHEREAS the Petitioners above named through their Advocate M/S BHARADWAJ ASSOCIATES presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate writ declaring that the order of the 2nd respondent in Revision Case No. B1/88/2016, File No.B1/1019 (2)/2016, dated 23.07.2016 relating to the subject land admeasuring Ac.5-11 guntas in Sy.No.350 of Elikatta village, Farooqnagar Mandal, Ranga Reddy District, as against the orders passed by the 3rd respondent - Revenue Divisional Officer in File No. B/ROR/73/2011, dated 22.12.2015 and keeping the revision petition pending all these years, is arbitrary, illegal and unsustainable in law and resultantly set aside the said order of status quo passed by the 2nd respondent in the above said revision case and direct the respondents not to interfere with the possession and enjoyment of the petitioners over the subject land admeasuring

Ac.5-11 guntas in Sy.No.350 of Elikatta village, Farooqnagar Mandal, Ranga Reddy District.
