WHEREAS the Petitioner above named through his Advocate A YADAVA REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction or writ, more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not releasing bills for an amount of Rs. 21,98,019/-in respect of Agreement No.AEE3 /98/ 2022-23, dated 01-03-2023 (Devunigutta), an Amount of Rs. 23,33,369/-in respect of Agreement No.AEE3/99/2022-23, dated 01-03-2023 (Sikindapur), an amount of Rs.3,80,985/- in respect of Agreement No.81/2022-23, dated 31-03-2023 (Watpally- Shadnagar), and an amount of Rs. 26,08,432/-in respect of Agreement No.AEE3/ - /2022-23, dated 05-01-2023 (Watpally- Paladugu,) signed by the 7th respondent for the civil works executed by the petitioner as arbitrary and illegal and violative of Articles 14, 19(1)g and 21 of the Constitution of India, and consequently direct the respondents herein, to release the bills for Rs. 21,98,019/-in respect of Agreement No.AEE3/ 98/ 2022-23, dated 01-03-2023 (Devunigutta), an amount of Rs.23,33,369/-in respect of Agreement No.AEE3/99/2022-23, dated 01-03-2023 (Sikindapur), an amount of Rs.3,80,985/- in respect of Agreement No.81/2022-23, dated 31-03-2023 (Watpally-Shadnagar), and an amount of Rs.26,08,432/- in respect of Agreement No.AEE3/ - /2022-23, dated 05-01-2023 (Watpally- Paladugu,) with 18 % interest from the date of actual due for payment to till the date of payment.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri A YADAVA REDDY Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
