Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ, order or a direction, more particularly one in the nature of Writ of Mandamus to declare the action of the respondents in mutating the land in Survey No.174/A1/A2 admeasuring Ac.2.30 guntas situated at Marikal Village, Thimmajipet Mandal, Nagarkurnool District, in favour of the non-official respondent/4th respondent, as being illegal, arbitrary, unreasonable and contrary

to the provisions of Telangana State Rights in Land and Pattadar Pass Books Act, 2020 and contrary to the judgment and decree passed in O.S.No.424 of 2023 and further action of the respondents in reserving a slot for further alienation by non-official respondent, vide application, No.2400204103 is equally arbitrary, illegal and detrimental to the valuable property rights of the petitioners herein and issue a consequential direction directing the official respondents to delete the name of non-official respondent/4th respondent as pattadar of the above mentioned land and implement the judgment and decree passed in O.S.No.424 of 2023 by recording the names of the petitioners herein as pattadars in place of our sister late Smt. B. Tirupathamma, w/o. B. Madusudhan Reddy.

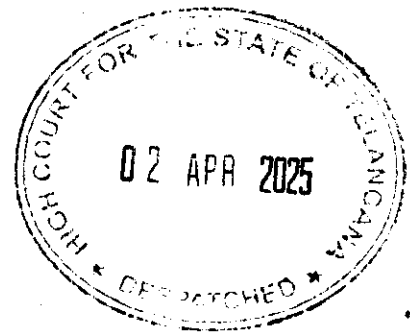
