WHEREAS the Petitioner above named through their Advocate Sri KARUNAKAR REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondent Nos. 3 and 4 herein in fixing the Stone Kadies with barbed wire in the petitioners land in Sy.Nos.83/1/A/2, 82/2/AA/2 and 83/1/A/1/2 admeasuring Ac. 1.05 gts.,Ac. 0.20 gts., and ac. 0.20 gts., situated at Palvanha village and Mandal, Bhadradi Kothagudem District at the behest of the unofficial respondents under the guise of the decree in O.S.No. 263 of 2011 on the file of the Principal Junior Civil

Judge at Kothagudem though the petitioners herein are not the parties and the suit property is different, as being illegal, arbitrary, unconstitutional, unwarranted and against to the principles of natural justice and consequently direct the 2nd respondent herein to take action against the respondent Nos. 3 and 4 and their subordinates for adopting illegal methods without verifying the records.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri KARUNAKAR REDDY Advocate for the Petitioner, directed issue of notice to the Respondent Nos. 5 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.
