WHEREAS the Petitioner above named through his Advocate SRI N. NARSIMULU presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to Issue a Writ, Order, or Direction, more particularly one in the nature of a Writ of Mandamus, declaring the action of the Respondent Nos. 2, 3, and 4 in failing to act upon the Petitioner's representation dated 10.12.2025 and cancel the fraudulent revenue entries in the names of Respondent Nos. 5, 6, and 7 pertaining to the land admeasuring Ac. 4.15 Guntas in Survey No. 90 of Masanpally Village, Gundala Mandal, Yadadri Bhongir District, as illegal, arbitrary, and violative of the principles of natural justice and to issue a consequential direction to the Respondent Nos. 2, 3, and 4 to forthwith cancel the fraudulent entries in the revenue records and the Pattadar Passbooks bearing Nos. T23050070008, T23050070332, and 23050070312 issued in the names of Respondent Nos. 5, 6, and 7 respectively.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI N. NARSIMULU Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
