WHEREAS the Petitioner above named through his Advocate SRI G RAVINDAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ, order or direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the 2nd respondent in issuing order vide Proc.No.D2/TM33/240034909/2024 dt.Nil-07-2024 by rejecting the online application No.240034909 dt.30-05-2024 in Meeseva/Dharani Portal for digital sign to the land admeasuring Ac.10.00 gts. in Sy.No.12211, situated at Sarsala Village, Kaghaznagar Mandal, Kumaram Bheem Asifabad District belongs to the petitioner basing on the complaint filed by the 6th respondent as illegal, arbitrary, unjust. unreasonable, against the principles of natural justice and contrary to the Section 5 of Bhu Bharati Act, 2025 and consequently direct the respondents 2 to 5 particularly the 5th respondent to issue digital pattadar passbook in respect of land admeasuring Ac.10.00 gts. in Sy.No.122/1, situated at Sarsala Village, Kaghaznagar Mandal, Kumaram Bheem Asifabad District in favour of the petitioner by considering the online application No.240034909 dt.30-05-2024.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI G RAVINDAR Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
