WHEREAS the Petitioners above named through their Advocate SRI CHAVALI RAMANAND presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate Writ or order or direction more particularly in the nature of WRIT OF MANDAMUS declaring action of the respondents more particularly that of the 4th Respondent in entertaining the Application of the 5th respondent in Application No. 2500648516 and proceeding ahead for mutating the revenue records for altering the entries therein and trying to enter the name of the 5th respondent therein or issuing the 5th respondent with pattadar pass books or title deed with respect to the lands (i) Agricultural land admeasuring Ac.0.1500 gts in Sy.No.294/1, Ac.2.04 gts, in Sy No.s 295, Ac.1.22 gts, in Sy No.s 296, Ac. 0-37 guntas, in Sy No. 297/1, Ac.0.37 gts, in Sy No.s 297/2, Ac.1.26 gts, in Sy No.s 298, total land admeasuring Ac.7.21 gts, situated at Akulamailaram Village, Meerkahnpet Revenue, Kandukur mandal, Ranga Reddy Dist., and (ii.) Agricultural land admeasuring Ac. 0.21 guntas in Sy No. 322/7, Ac. 0.19 guntas in Sy No. 323/2aa/1 total land admeasuring Ac.1.00 gts, situated at Akulamailaram Village, Meerkahnpet Revenue, Kandukur mandal, Ranga Reddy Dist. as arbitrary, erroneous, illegal, highhanded, improper, colorable, and unjust exercise of power, authority and jurisdiction and further, it is unconstitutional, contrary and violative of provisions of the Telangana Bhu-Bharathi (Record of Right in Land) Act 2025, the rules made thereunder as well as the provisions of the Telangana Rights in Land and Pattadar Pass Books Act, 2020 and also violative of

Articles 14, 21, 300-A of the constitution of India to consequently quash and set aside the same.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI CHAVALI RAMANAND Advocate for the Petitioner, Assistant Government Pleader for Revenue for respondent Nos.1 to 4, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Issue notice to respondent No.5.

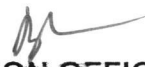
Learned counsel for the petitioners is permitted to take out personal notice to respondent No.5 and file proof of service by the next date of hearing.
