ORDER

Learned Additional Public Prosecutor takes notice on behalf of respondent No.1 and seeks a week's time.

Learned counsel for the petitioner fairly submitted that the matter before the trial Court is at the stage of summons.

The presence of the petitioner/accused in P.R.C.No.4 of 2026 on the file of the I Additional Junior Civil Judge-cum-I Additional Judicial Magistrate of First Class at Malkajgiri, Medchal Malkajgiri District, is dispensed with, subject to the condition that he shall be represented through his counsel on each and every date of hearing. If the presence of the petitioner/accused is required, he shall appear before the trial Court. In case of non-appearance on the specific date fixed by the trial Court for his appearance, the trial Court is entitled to proceed with the matter, in accordance with law.
