WHEREAS the Petitioners above named through their Advocate SRI SHAFATH AHMED KHAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a , Writ of Mandamus or any other appropriate Writ, order or direction declaring the high handed action of the Respondents in proposing to establish integrated Schools of 5th Respondent in the land of the Petitioners in Sy.No.98 to an extent of Ac.4.00 Gts, situated at Thonda Village, Thirumalgiri Mandal, Suryapet District without notice, without following due process of law is arbitrary, illegal, without authority and in violation of Article 14, 300-A of Constitution of India and Principles of Natural Justice consequently to Restrain the Respondents from establishing 5th Respondent School in the land of the Petitioners in Sy.No.98 to an extent of Ac.4.00 Gts, situated at Thonda Village, Thirumalgiri Mandal, Suryapet District, in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of SRI SHAFATH AHMED KHAN Advocate for the Petitioners and GP FOR REVENUE for the Respondents No. 1 to 4 directed issue of notice

to the Respondent No.5 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 27.04.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

IA NO: 1 OF 2026

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to pass interim Stay Restraining the Respondents from taking away the subject land of the Petitioners in Sy.No.98 to an extent of Ac.4.00 Gts, situated at Thonda Village, Thirumalgiri Mandal, Suryapet District, from the Petitioners high handedly without notice and without following due process of law for the establishment of 5th Respondent School, pending disposal of WP No.10128 of 2026, on the file of the High Court.

The Court made the following

ORDER:

Issue notice to respondent No.5.

Learned counsel for the petitioners is permitted to take out personal notice to respondent No.5 and file proof of service by the next date of hearing.

The petitioners are claiming patta and ownership over the subject land admeasuring Acs.4-00 guntas in Survey No.98 situated at Thonda Village, Thirumalgiri Mandal, Suryapet District, by virtue of e-pattadar pass book bearing Nos.T29220041346, T29220040387, T29220041345 and T29220041347. It is alleged that respondent No.5 is trying to construct School in the land of the petitioners without following due process of law and without acquiring the land of the petitioners.

As the petitioners claim title over the subject land on the strength of e-pattadar pass books, there shall be interim direction to respondent No.5 not to interfere with the possession and enjoyment of the petitioners over the subject land without following due process of law.
