Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to retain/allot the petitioner to Zone-V1, Charminar by suspending the operation of the impugned proceedings of allotment to Zone-V11, Jogulamba bearing No. HM/D1/ZVI/Z1V/MUPU/0090, dated 30/12/2021, issued by the 2nd respondent, pending disposal of WP No. 16021 of 2022, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following order.(The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

Heard learned counsel for the petitioner, learned Government Pleader for Medical and Health appearing for the respondents and perused the record.

Petitioner contends that against the allotment order dt.30.12.2021, petitioner filed an appeal to the appropriate authority on 01.01.2022 and the said appeal is pending consideration.

It is further contended that the respondents have issued posting orders in contravention of instructions issued in G.O. Ms. No.124 GA (SPF-MC) Department, dated:30-08-2018.

Without expressing any view on the said contention urged, since it is admitted that the petitioner has already availed the remedy as provided under Regulation 27 of the Guidelines issued under G.O. Ms. No.317, General Administration (SPF-I) Department, dated 06.12.2021, the respondents are directed to dispose of the said appeal on or before 30.04.2022 in accordance with law.

It is further made clear that while considering the appeal, the respondents shall keep in consideration the intent and purport behind the Circular instructions issued vide G.O. Ms. No.317 dt.06.12.2021 and Circular Memo No.1655/SPF-I/2021-7, dt.23.12.2021 by the Chief Secretary to Government relating to posting of employees in newly allotted cadre.
