ORDER:

Learned counsel for the petitioners submitted that, in similar circumstances, this Court passed order dated 05.12.2025 in WP.No.33661 of 2025 and requested to pass similar order in the instant writ petition also.

In view of the above, status quo, obtaining as on today, shall be maintained by all parties in all respects. However, this order shall not come in the way of the respondent authorities in taking action against the petitioner by following due process of law.
