WHEREAS the Petitioner above named through his Advocate SRI MOHD ASIFUDDIN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or direction one in the nature of Mandamus declaring the action of the respondents in trying to validate the fake 13-B certificate bearing Proceedings in Rc.No. 1858/2012 dated 24/09/2012 which corresponds to Birth Certificate as per Register of 2012 illegally mentioned in respect of land in Survey No. 130/ 1 to an extent of Ac.5-14 guntas situated at Ramsagar Village, Komaravelli Mandal, Siddipet District is arbitrary and illegal and consequently issue a direction to the respondents to conduct enquiry and take action as per law against the concerned;
