The interim order granted earlier is extended till 28.09.2020.

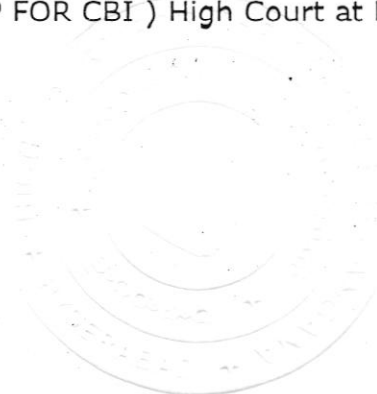
