Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, order or direction, more particularly one in the nature of writ of Mandamus i. Declaring the actions of the Respondents in obtaining undertaking dated 25.03.2025 from the Petitioner under coercion and duress as illegal, arbitrary, unjust, and unconstitutional and consequently declare the undertaking dated 25.03.2025 as null and void and not binding/consequently set aside the same. ii. Consequently direct the Respondent authorities not to take any coercive steps/actions on the basis of undertaking dated 25.03.2025 including not demanding for any monies iii. Consequently direct the Respondent authorities to forthwith commence the lifting of paddy lying at the Petitioner Rice Mill pertaining to Crop Year Rabi 2022-2023 in terms of Global E- Tender dated 25.01.2024 on 'as is where is' basis

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents not to take any coercive action against the Petitioner Rice Mill except to the extent of lifting of paddy pertaining to Crop Year Rabi 2022-2023 in terms of Global E- Tender dated 25.01.2024 on 'as is where is' forthwith basis pending disposal of the present Writ Petition.

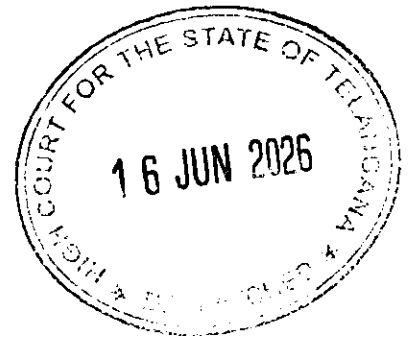
