WHEREAS the Petitioner above named through their Advocate Sri B A PRAKASH REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue writ, order or direction, more particularly one in the nature of Writ of Mandamus by declaring the action of the respondents 4 to 6 in interfering with the civil disputes in respect of the Patta Land of the petitioners in Sy.No.180 admeasuring Acs.11-39 gts and Sy.No.120 admeasuring Acs.O-21 gts situated at Polepally village, Amangal Mandal, Ranga Reddy District in illegally and forcibly removing the Fencing and Gate from the Patta Land of the Petitioners, at the behest of the unofficial respondents and threatening, insisting and directing the petitioners to settle the civil disputes with the unofficial respondents, as illegal, arbitrary unjust and nothing but misuse of their official powers and consequently direct the respondents 4 to 6 not to interfere with the civil disputes pending between petitioners and unofficial respondents, in the interest of justice.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri B A PRAKASH REDDY Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Learned counsel for the petitioners is permitted to take-out personal notice to respondents No.9 to 13 and file proof of service by the next date of hearing.

There shall be interim direction to respondents No.5 and 6 not to interfere in the civil disputes pending between the petitioners and respondents No.9 to 13 without following due process of law.
