WHEREAS the Petitioners above named through their Advocate Sri. PARAVASTU KRISHNA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an appropriate writ, or order or direction, more particularly, one in the nature of Writ of Mandamus, declaring the inaction on the part of the respondents 2 to 4 in not taking any action on the representation of the petitioners dated 22-05-2019 seeking to restrain the respondents 5 to 7 herein from making further illegal and unauthorized constructions in the property of the petitioners admeasuring Ac.0-14 Gts. In Sy. No. 14/1, situated at Madhapur, Serilingampally Mandal, Ranga Reddy District (formerly Khanammet Village, Serilingampally Mandal, RR District) without obtaining any sanctioned plan from the respondents 2 to 4 herein as highly illegal, arbitrary and unconstitutional being violative of Articles 14, 21 and 300-A of the Constitution of India and also violative of principles of natural justice and consequently direct the respondents 2 to 4 herein to dispose of the representation dated 22-05-2019 made by the petitioners herein within a reasonable time by directing them to restrain the respondents 5 to 7 herein from making any further illegal and unauthorized constructions in the property

of the petitioners admeasuring Ac.0-14 Gts. In Sy. No. 14/1, situated at Madhapur, Serilingampally Mandal, Ranga Reddy District (formerly Khanammet Village, Serilingampally Mandal, RR District) without obtaining any sanctioned plan from the respondents 2 to 4 herein.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri. PARAVASTU KRISHNA Advocate for the Petitioners and SC for GHMC, directed issue of fresh notice to the Respondent Nos. 5 to 7 herein to show cause as to why this WRIT PETITION should not be admitted.
