WHEREAS the Petitioner above named through his Advocate Sri D.V..Chalapathi Rao, presented this Petition under Article 226 of the Constitution of India, praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondent No. 3 proceeding with mutation of the petitioner's agricultural land admeasuring an extent of Acr.2.00 gts in Sy. 61/B/3 situated at Chowdaram Village, Jangoan Mandal and District in favor of respondent Nos. 4, 7, 9, 12, and 13 based on a final decree passed in O.S. No. 115 of 2012 on the file of the Senior Civil Judge at Jangoan, pending adjudication of the suit filed by the petitioner in O.S. No. 507 of 2019 on the file of Addl. Junior Civil Judge at Jangoan for declaration of title, possession, and cancellation of the preliminary and final decree in O.S.No. 115 of 2012 as illegal, arbitrary, against the principles of natural justice, fair play, and in violation of Art. 14 and 300-A of the Constitution of India and against the settled law;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri D.V.Chalapathi Rao, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.

Petition under Section 151 of CPC, praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct the respondent No. 3 not to proceed with mutation of petitioner's agricultural land admeasuring an extent of Acr.2.00 gts in Sy. 61/B/3 and Acr. 0.14 gts in Sy. No. 61/C/1 situated at Chowdaram Village, Jangoan Mandal and District in favor of respondent Nos. 4 to 13 in the revenue records, by staying all further proceedings in Rc. No. B/876/2020 dated 19.03.2020 on the file of the respondent No.3 concerning the petitioner's land, pending disposal of WP No. 13512 of 2020, on the file of the High Court.
