WHEREAS the Petitioner above named through his Advocate SRI AYYORI SRIDHAR MITHA AYYALVAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ of Mandamus, declaring that the inaction of Respondents No. 1 to 5 in considering the representations of the petitioner dated 30.07.2024, 29.08.2024, 03.05.2025, 17.05.2025 and 01.11.2025 respectively, as arbitrary, illegal, improper, unjust, contrary to the provisions of The Air (Prevention and Control of Pollution) Act, 1981 and The Environment (Protection) Act, 1986, violative of Article 14 and 21 of the Constitution of India and direct the Respondents

No.1 to 5 herein, to consider and dispose of the representations of the petitioner dated 30.07.2024, 29.08.2024, 03.05.2025, 17.05.2025 and 01.11.2025 respectively with regard to the inspection of the mill premises of the 6th respondent, situated in the Residential area as well as the surrounding residential area, by issuing appropriate direction to shift 6th Respondent-Mill to the Industrials Area at SEZ.

AND WHEREAS the High Court upon perusing the petition and memorandum of grounds filed herein and upon hearing the arguments Of SRI. AYYORI SRIDHAR MITHA AYYALVAR Advocate for the Petitioner, directed ssue of notice to the Respondent No.6 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 11.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

The Court made the following:

ORDER

Issue notice to the 6th respondent.

Learned counsel for the petitioner is permitted to take out personal notice on the 6th respondent through Speed Post with Acknowledgment. Due and file proof of service thereof into Registry.

Sri Zeeshan Adnan Mahmood, learned Counsel appearing for the 3rd respondent, on instructions, would submit that the 3rd respondent has already seized 6th respondent unit, they have dismantled the boiler. The 6th respondent is only doing categorization of manual grinding of groundnuts. He seeks time to file counter.

However, learned counsel for the petitioner disputes the same and he has filed additional affidavit vide USR No.49042 on 16.04.2026.

Sri Putta Krishna Reddy, learned Standing Counsel for 4th respondent, on instructions, would submit that he also seeks time to file counter.
