KARTHIK NAVAYAN presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction, more particularly one in the nature of Writ OF MANDAMUS declaring the inaction of the Respondents on appeal of the Petitioner dated 02/01/2022 and representation dated 22/03/2022 against the allocation proceedings vide proceedings vide Proc No.HM/CO/MA/ZIV/MUPU/0279 dated 31/12/2021 and Proceedings No.HM/CO/ZIV/MUPU/0004 dated 10/01/2022 issued by Respondent No.3 as arbitrary illegal discriminatory malafide unconstitutional violating Articles 14 and 21 of the Constitution of India as well as against the direction of Division Bench of this Court in W.P.No.9798 of 2022 and set aside the same and issue consequential directions to respondents to reallocate the Petitioner to Zone VI Charminar in the interest of Justice and render Justice.
