WHEREAS the Petitioner above named through her Advocate SRI P UGENDER REDDY presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue an order or direction, more particularly one in the nature of Writ of Mandamus, declaring the action of the respondents herein in allotting the petitioner to the local cadre of Nagarkurnool District vide impugned Proc. No.PR/PR/MA/NAGA/JUAS/0086 dated 16/12/2021 and its consequential posting order vide proc.No.PR/PA/NAGA/JUAS/0002 dated 31/12/2021 of 1st respondent setting aside the same by holding it as illegal, arbitrary, discrimination, unfair, unjust, contrary to the rules, orders issued by the government in G.O Ms No.317 dated 06/12/2021 and Memo No.1655/SPF.I/2021-8 dated 24/12/2021, apart from violation of constitutional provisions and consequently direct the respondents to consider the case of the petitioner for re-allocation to the Ranga Reddy district local cadre under special category of 100 Percent Hearing Impairment Handicapped in terms of guideline No.22 of G.O.Ms.No. 317 dated 6/12/2021 as well as on spouse grounds with all consequential benefits;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri P UGENDER REDDY Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
