WHEREAS the Petitioner above named through it Advocate SRI. G. ANIL KUMAR presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ or Direction Preferably Writ of Mandamus, declaring the action of the Respondents No. 4 and 5 in interfering in civil disputes and trying to dispossess the Petitioner from his land in Sy. No. 633 part admeasuring to an extent of Ac. 0-19 gts, Sy. No. 633 part admeasuring to an extent of Ac. 0-10 gts, Sy. No. 633 admeasuring to an extent of Ac. 0-09 gts, Sy. No. 633 part and Sy.No.635 admeasuring to an extent of Ac. 1-00 gts and Sy. No. 635 admeasuring to an extent of Ac. 1-00 gts together completely an extent of Acr 2-38 Gts land situated at Shamshabad village and Gram Panchayath, Shamshabad Mandal, Rangareddy District, as illegal, arbitrary, and violation of principles of natural justice and violation of Article 14 and 21 of the Constitution of India and consequently direct the Respondents No. 4

and 5 not to call the Petitioner and not to harass the Petitioner in respect of subject land in any manner without following due process of law;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri G. ANIL KUMAR Advocate for the Petitioner, directed issue of notice to the Respondent Nos.6 to 9 herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 10.06.2024 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the Respondents No. 4 and 5 not to interfere in civil disputes and not to harass Petitioner at the instance of the Respondents No. 6 to 9 in respect of land in Sy. No. 633 part admeasuring to an extent of Ac. 0-19 gts, Sy. No. 633 part admeasuring to an extent of Ac. 0-10 gts, Sy. No. 633 admeasuring to an extent of Ac. 0-09 gts, Sy. No. 633 part and Sy.No.635 admeasuring to an extent of Ac. 1-00 gts and Sy. No. 635 admeasuring to an extent of Ac. 1-00 gts together completely an extent of Acr 2-38 Gts land situated at Shamshabad village and Gram Panchayath, Shamshabad Mandal, Rangareddy District, pending disposal of WP No. 11544 of 2024, on the file of the High Court.

The Court made the following:

ORDER:

Learned Assistant Government Pleader for Home seeks time to get instructions.

Respondent Nos.4 and 5 are directed not to interfere in civil disputes pending between the petitioner and respondent Nos.6 to 9 in connection with the land admeasuring Acs.0-19 guntas in Survey No.633 Part, Acs.0-10 guntas in Survey No.633 part, Acs.0-09 guntas in Survey No.633 part and Ac.1-00 guntas in Survey No.635 and Ac.1-00 guntas in Survey No.635, total land to an extent of Acs.2-38 guntas, situated at Shamshabad Village and Gram Panchayat, Shamshabad Mandal, Rangareddy District, until further orders. However, this order shall not have any bearing on the disputes with regard to title and possession between the petitioner and respondent Nos.6 to 9.

Issue notice to respondent Nos.6 to 9.

Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.6 to 9 and file proof of service.
