WHEREAS the Petitioner above named through his Advocate Smt A CHANDRAVATHI presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to.

- I.) Issue a Writ of Mandamus or any other appropriate writ, order direction, directing Respondents 1 to 4 to provide adequate public protection to the life, limb and property of the Petitioner, who is a poor SC (Madiga) assigned land holder being terrorized and threatened with death by politically influential accused persons
- II.) Issue a Writ of Mandamus or any other appropriate writ, order a direction, directing Respondent No.5 (MRO, Nereducherla) to stop entertaining the unlawful claims of the private Respondents over the Petitioner's assigned patta land and to protect the lawful revenue records standing in the name of the Petitioner
- III.) Issue a Writ of Mandamus or any other appropriate writ, order or direction, directing Respondent No.6 (TSSPDCL) to forthwith remove the electrical transformer illegally erected on the Petitioner's assigned patta land Sy.No.262/Roo without consent or lawful permission, and to restore the land to the Petitioner.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Mrs A CHANDRAVATHI Advocate for the Petitioner, Sri M.Srinivas, Assistant GP FOR HOME, for the respondent Nos. 1 to 4, Sri K.Mahesh, Assistant GP FOR REVENUE, for the respondent No.5 and Sri N Sridhar Reddy, standing Counsel for the respondent No.6 directed issue of notice to the Respondent Nos. 7 to 14, herein to show cause as to why this WRIT PETITION should not be admitted.

are directed to show cause on or before 17.06.2026 to which date the case stands posted as to why in the circumstances set out in the petition and the affidavit filed therewith (copy enclosed) this WRIT PETITION should not be admitted.

**I.A. NO: 1 OF 2026**

Petition under Section 151 of C.P.C praying that in the circumstances stated in the affidavit filed in support of the writ petition, the High Court may be pleased to direct Respondents 1 to 4 to provide immediate police protection to the Petitioner, his family members and his patta land in Sy.No.262/Roo, Fathepuram Revenue Village, Nereducherla Mandal, Suryapet District; to refrain from taking any coercive action against the Petitioner in Crime No.45/2023 during the pendency of this Writ Petition; and to direct Respondent No.6 (TSSPDCL) to maintain status quo with respect to the illegally erected transformer on the said land, pending disposal of WP No 11376 of 2026, on the file of the High Court.

**The Court made the following:**

**ORDER**

**Notice before admission.**

**Sri M.Srinivas, learned Assistant Government Pleader for Home, takes notice for respondent Nos.1 to 4, waives further notice and seeks time to get instructions or file counter-affidavit. Sri K.Mahesh, learned Assistant Government Pleader for Revenue, takes notice for respondent No.5 and waives further notice. Learned Standing Counsel for TSSPDCL takes notice for respondent No.6 and waives further notice.**

**Learned counsel for the petitioner is permitted to take out personal notice to respondent Nos.7 to 14 by Speed Post with Acknowledgment Due and file proof of service before the Registry by the next date of listing.**

Learned counsel for the petitioner would submit that the petitioner is the owner and possessor of the land admeasuring Acs.4.18 guntas in Sy.No.262/Roo, situated at Fathepuram Revenue Village, Nereducherla Mandal, Suryapet District, having acquired the same through D-Form Laoni Patta bearing No.8820013043 vide File No.28/3187/2010, dated 12.04.2010 and his name was incorporated in all the revenue records and he was also issued pattadar passbook and title deed bearing No.1080308 vide Patta No.155. Learned counsel for the petitioner would further submit that when respondent No.9 and one Dara Saramma are interfering with the possession of the petitioner over the subject property, he was constrained to file a suit for perpetual injunction vide O.S.No.433 of 2022 on the file of the Junior Civil Judge, Huzurnagar and the said Court also granted *ad interim* injunction in favour of the petitioner in I.A.No.1486 of 2022, dated 14.11.2022 and subsequently the same was extended until further orders. The grievance of the petitioner is that while the unofficial respondents are violating the said injunction order, respondent No. 4 is supporting them without following the procedure contemplated under law.

The said aspect is required detailed examination and the facts can only be ascertained after filing of the counter-affidavit.

Pending filing of the counter-affidavit, there shall be interim direction to respondent No.4 not to interfere with the *inter se* private disputes pending between the petitioners and the unofficial respondents, except following due process of law.
