WHEREAS the Petitioner above named through his Advocate SRI SRINIVAS KUDUMULA presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or direction particularly one in the nature of Writ of Mandamus declaring the proceedings.No.PR/PR/ AD/KOMA/REAS/0034 dated 22/12/2021 issued by the 4th respondent in allotting the petitioner to new place Komaram Bheem Asifabad District from petitioner's old place of work i.e. Adilabad District and consequential proceedings of the 5th respondent vide Procs. No. PR/PA/ KOMA/REAS/ 0004 dt. 31/12/2021 directing me to report in new place Komaram Bheem Asifabad District within three days from the date of order instead of allotting the petitioner to Kamareddy District, and not considering the petitioner's representation dated 08/03/2022 to the 6th respondent on nativity grounds, in terms of Instruction No.23 annexed to GO Ms No.317 GAD dated 06/12/2021 as well as Instruction No.11 of Circular Memo No.1655/SPF.I/2021-7 dated 23/12/2021 issued by the Government, as illegal, arbitrary, violative of principles of natural justice and also violative of fundamental rights as guaranteed under Articles 14, 16, and 21 the Constitution of India and consequently set-aside the same;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri SRINIVAS KUDUMULA, Advocate for the Petitioner, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
