WHEREAS the Petitioners above named through their Advocate Sri Lakkadi Dayaker Reddy presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of Writ of Mandamus by declaring the action of the Respondents in not following the local and non local reservation properly and not filling-up the non joining vacancies and not carry forwarding the left over vacancies in respect of DSC-1998 in Karimnagar district and not following the Government Orders in the matter of recruitment, thereby not appointing the petitioners as Secondary Grade Teacher in DSC-1998 although they comes within the zone of consideration if all the above procedure is strictly followed as arbitrary, illegal and consequently declare that the petitioners are entitled to be appointed as SGT pursuant to DSC-1998 notification and issue appointment orders.

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri Lakkadi Dayaker Reddy Advocate for the Petitioners, directed issue of notice to the Respondents herein to show cause as to why this WRIT PETITION should not be admitted.
