WHEREAS the Petitioner above named through his Advocate SRI M A BASITH presented this Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, Order or Direction more particularly one in the nature of WRIT OF MANDAMUS declaring that the impugned proceedings No. A1/41/25, dated 04.04.2025 issued by the Respondent No.2 by cancelling and deleting the Door No.6-36 of the Petitioner's House property from the municipal records without considering the documents submitted by the Petitioner on 20.03.2024 and also without according an opportunity of hearing to the Petitioner is wholly illegal, unjust, void and unconstitutional and against the principles of natural justice and consequently the Honble Court may be pleased to suspend the impugned proceedings No. A1/41/25, dated 04.04.2025 issued by the Respondent No.2 by cancelling and deleting the Door No.6-36 of the Petitioner's House property from the municipal records pending disposal of the main Writ Petition in the interest of justice;

AND WHEREAS the High Court upon perusing the petition and affidavit filed herein and upon hearing the arguments of Sri M A BASITH, Advocate for the Petitioner, directed issue of notice to the Respondent No.3 herein to show cause as to why this WRIT PETITION should not be admitted.
