Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the petition, the High Court may be pleased to suspending the sentence/Judgment dated 18/01/2022 made in Criminal Appeal No.50 of 2018 on the file of the court of III Additional Sessions Judge at Karimnagar confirming the sentence/Order dt.18/01/2018 in C.C.No.92 of 2012 on the file of the court of the Special Magistrate at Karimnagar pending disposal of CRLRC No. 235 of 2022, on the file of the High Court.

The Court made the following

ORDER

This application is filed seeking suspension of sentence that is imposed on the petitioner.

Learned counsel for the petitioner states that the petitioner is convicted for the offence punishable under Section 138 of Negotiable Instruments Act, 1881 through judgment in C.C.No.92 of 2012, dated 18.01.2018 that is rendered by the Court of Special Magistrate, Karimnagar, and she was sentenced to pay a fine of Rs.5,00,000/- and the appeal filed by the petitioner was dismissed vide judgment that is rendered by the Court of III Additional Sessions Judge, Karimnagar, in Crl.A.No.50 of 2018, dated 18.01.2022. Learned counsel states that the petitioner has not committed any offence and, therefore, the sentence imposed upon her has to be suspended.

Having considered the said submission, the sentence imposed upon the petitioner shall stand suspended till disposal of the Criminal Revision Case on the petitioner executing a personal bond for Rs.20,000/- with two sureties for a like sum each to the satisfaction of the Court concerned and on depositing 30% of the cheque amount.
